LYNN HANSON GALLERY invites artists to submit up to 3 pieces of 2D or 3D art. Entry deadline, **August 8, 2021**

We are looking for artists' unique interpretation of the theme **ICON**. (**ICON** can be any subject or abstract glorified - thinking outside the box on the theme is encouraged)

The show is open to all visual artists: painting, drawing, photography, sculpture, glass, collage and assemblage. We will also consider sound, video or film if artists provide technical setup.

Pieces selected will be exhibited at LYNN HANSON GALLERY for the month of September 2021, September 2-25. Gallery will be open First Thursday Art Walk Sept 2, 5-8 pm (if covid permits, if not art walk will be virtual), Fridays and Saturdays, 11-4 pm

2021 Juror for Acceptance and Awards: **Dawn Laurant**

Dawn Laurant Artist Bio:

Dawn Laurant brings over 30 years of experience in the arts as a curator, educator and appraiser. Originally from San Francisco, she worked for Bay Area museums including the Asian Art Museum of San Francisco and the Marin History Museum as Senior Curator and Exhibit Designer. She received her M.A. in Museology from John F. Kennedy University, with graduate studies through UC Berkeley, on archaeological excavations in Pakistan and Tunisia and in Florence, Italy. Locally, Dawn has curated and juried exhibitions at Ryan James Fine Arts, Howard/Mandville, and Redmond Arts Festival, and was Executive Director and Curator at VALA Art Center. In addition, Dawn holds a certificate in Fine Art Appraisal from UC Irvine and manages an appraisal business

where she facilitates appraisals of collections for private clients and public institutions, as well as for the trust and estate community. Dawn is an active volunteer with several arts organizations including Kirkland Summerfest Art Festival and the National PTA Reflections Art Program, and has served eight years on the Kirkland Cultural Arts Commission. Alongside her work in the arts community, Dawn is an artist and her paintings have been included in group shows at the Kirkland Art Center, Lynn Hanson Gallery, VALA and Museum of Northwest Art.

- Email images in digital format. Either email or send CD.300 DPI resolution at either 6" or 1800 pixels on the longest side. Files should not exceed 2 MB. For 3D you can send 2 views per entry if this helps describe the work. Mail CD with paperwork or send jpegs via email: lynnhansongallery@gmail.com. Entries must be original and entirely the work of the entrant. No clones or reproductions will be accepted. Save each image with the following file name format: Last Name_1,2 or 3 (to correspond with your entry form), and title. Example: Smith_1_Title.jpg
All pieces must be for sale. Work must be entered and sold as presented in the application and image. Art will be juried from the submitted digital images. Awards will be chosen from original work after work is delivered. Art work must be priced for sale. Dimensions for wall art 48" maximum. Sculpture must be a size that can fit on a table (size 28"x45" or less). Sales will be handled between gallery and buyer only. Gallery will charge a 50% commission on sales. Artwork must be professional in appearance in its framing and presentation. Wall art must be properly prepared for hanging with D or O rings and wires. No sawtooth hangers. Frames must be in excellent condition. Wrapped canvases must have sides finished to gallery quality.
[LYNN HANSON GALLERY](#) reserves the right to refuse artwork that is delivered with sub-standard presentation or art not matching digital representation. Upon acceptance, artwork can be hand delivered to gallery on Saturday, August

29, from 3:00- 5:00, or Sunday, August 30, 12:00-2:00. Shipping instructions will be sent to those artists whose work has been accepted. Mailed shipments must be in reusable packaging and MUST have pre-paid return shipping labels for either UPS or Fed EX, with an additional \$10.00 handling fee. Artwork must remain for the duration of the show.

Innovative Use of Materials Award (chosen by the juror)

Strong Voice in Art Award (chosen by the juror)

People's Choice Award (the people vote, most votes received by a artist)

- September 2, 5-8—Opening Night, First Thursday Art Walk, Pioneer Square (may be virtual depending on covid restrictions)
- September 11 (Second Saturday) - Reception and awards, 2-4 PM, (may be on Zoom, depending on covid restrictions)
- Saturday, September 25, 4:00-5:00 or Sunday, September 26, 12:00-2:00— pick up art at gallery,

Entry fees are nonrefundable and must be paid in US currency. The gallery will exercise great care in handling and exhibiting all artwork, but will not be responsible for any loss or damage.

Artists are responsible for insuring their artwork to and from the exhibition. Applying for the show, and paying the \$30.00 fee does not guarantee a spot in the show.
